NOTICE OF PROPOSED RULE DEVELOPMENT WORKSHOP

SCHOOL BOARD POLICIES

The School Board of Orange County, Florida ("**Board**") will hold a public workshop on the following revised Board policies **IHAM** Local School Wellness, **JFABB** Foreign Exchange Students, **JFABC** International Student Admission, and **JJ** Extracurricular Activities on **December 5, 2023**, at the Educational Leadership Center ("ELC"), located at 445 West Amelia Street, Orlando, FL 32801. The revised Board policies will be placed on the Board's agenda for a public hearing during the **December 12, 2023**, meeting at the ELC, located at 445 West Amelia Street, Orlando, FL 32801.

Written comments may be submitted within 21 days of the date of this notice to Joanne L. Montalvo, Legal Services, ELC-9, 445 West Amelia Street, Orlando, FL 32801. Substantially affected persons may, within 14 days of the date of this notice, file an objection to this rulemaking with the Board. The objection shall specify the portions of the proposed rule to which the person objects and the specific reasons for the objections.

Policy IHAM Local School Wellness

Purpose and Effect: This policy is being revised to update statutory and federal law citations and to remove language relating to the use of Automated External Defibrillators ("AEDs"). Policy language complying with § 1006.165, FS, which requires an AED at each school, is more appropriately placed in Policy JJ Extracurricular Activities, which is also being reviewed for proposed revisions.

Summary: Revisions to the existing language includes content, formatting, and authority citations.

Policy JFABB Foreign Exchange Students

Purpose and Effect: This policy is being revised to update and clarify language, to add headings, and to update statutory provisions.

Summary: Revisions to existing language includes content, formatting, and terminology edits.

Specific Authority: §§ 1001.41 and 1006.07, FS

Policy JFABC International Student Admission

Purpose and Effect: This policy is being revised to update and clarify language, to add a provision requiring an annual tuition fee equal to the full, unsubsidized, per capita cost of the program to be charged to international students, to remove language regarding the international adult/technical students, and to update the statutory and rule citations.

Summary: Revisions to existing language includes content, formatting, and terminology edits.

Specific Authority: §§ 1001.41 and 1006.07, FS

Policy JJ Extracurricular Activities

Purpose and Effect: This policy is being revised to include supplemental programs and to add a new section requiring parental permission for participation in school-sponsored events, activities, and supplemental programs. In addition, § 1006.165, FS, requires each public school that is a member of the Florida High School Athletic Association to have an AED on school grounds, so a new section regarding AEDs has been added. Though AEDs were already included in Policy IHAM Local School Wellness, language complying with the statute is more appropriately placed in this policy.

Summary: Revisions to existing language includes content, formatting, and terminology edits.
